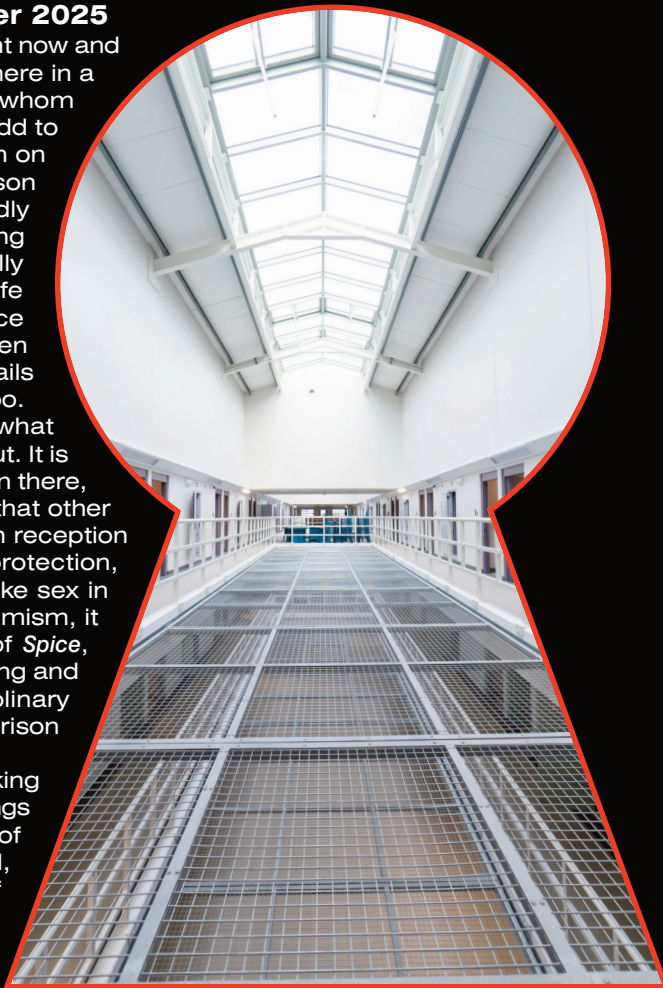

Over 87,500 people are in jail right now and last year over 400 people died there in a 30% increase on 2024 - 86 of whom took their own lives.
