Thank you for your e-mail of 26th June 2017, in which you ask for the following information:

1. Copies of all CPFIG fire safety inspection reports on prison and young offender establishments carried out in the last 12 months.
2. Details of the CPFIG inspection programme on prison establishments, for example how often are prison establishments inspected, who carries out those inspections, against what criteria are prison establishments inspected and to have copies of the same.
3. What procedures are in place for ensuring deficiencies in prison fire safety identified during a CPFIG inspection are corrected?

<p>2. Details of the CPFIG inspection programme on prison establishments, for example how often are prison establishments inspected, who carries out those inspections, against what criteria are prison establishments inspected and to have copies of the same.</p>	<p>CPFIG's inspections are aimed at identifying whether any person has failed to comply with the law. As we deliberately provide prisons with only limited warning of inspections, the details of our ongoing inspection programme are exempt from release under Section 31.</p> <p>CPFIG's risk-based inspection programme plans to inspect premises with sleeping accommodation (such as prisons) on a 3-5 year rolling programme, but the priority given to inspecting specific establishments must also take into account a range of risk indicators. These include the fire risk profile of prisons; the number and seriousness of fire incidents and injuries at that and in other prisons; as well as risk intelligence from other sources (such as HM Inspector of Prisons and HSE). This means that CPFIG inspectors inspect where the greatest risk may be present but also ensures that all prisons are included in the rolling programme of inspections.</p> <p>CPFIG undertakes post-fire investigations following significant fires and also uses interim "short audits" to update its risk profile for establishments which have not recently had an inspection. Each of these can change the priority given to carrying out an inspection of the establishment.</p> <p>Inspections consist of a two-day process involving either 3 or 4 CPFIG inspectors, depending on the complexity and size of the establishment.</p> <p>Judgments are reached against the inspection standard "FIRE SAFETY EXPECTATIONS IN PRISONS - Fire Safety Requirements for Residential Prison Accommodation". A copy of this is attached.</p>
<p>3. What procedures are in place for ensuring deficiencies in prison fire safety identified during a CPFIG inspection are corrected?</p>	<p>Prisons must comply with the Fire Safety Order but have immunity against prosecution if they fail to do so. CPFIG's approach to enforcement is to use 'Crown Notices' in place of statutory notices. These Notices are not enforceable but provide definitive statements of the fire safety deficiencies at any establishment and invariably result in the prison (with guidance from a multi-disciplinary stakeholder group led by the HMPPS National Fire Safety Team) developing and submitting an action plan for addressing the deficiencies.</p>

CPFIG carries out follow-up action after every inspection, to confirm that the action plan is being progressed. The follow-up action usually takes the form of a further limited inspection, but we may simply request a written assurance on progress from the Governor where that is appropriate. The findings of the follow-up action are then used to identify whether further enforcement action is required, based on the Enforcement Management Model (see https://www.google.co.uk/url?sa=t&rct=j&q=&esrc=s&source=web&cd=2&cad=rja&uact=8&ved=0ahUKEwiroK2Ko4jVAhVD_WMKHe-JBS4QFggmMAE&url=http%3A%2F%2Fwww.cfoa.org.uk%2Fdownload%2F62582&usq=AFQjCNH03tezQsyR7pyuABfHkSMazDVYPg). This can lead to enforcement being stepped up where inadequate progress has been made.
